5 min Trustee's Report: Melissa Copley

- Focus on staffing transitions, specifically with the incoming superintendent.
- Municipal election in fall which includes school board trustees
- Transportation follows a cost recovery model; slight increase for 2025/26 school year
- Conversation re wording on the Assurance Survey; difficult to interpret results; the concern has been raised with the province but no changes have been made.

- Staffing changes
 - → 3 temporary hires to be made for maternity leaves
 - → 3 FT probationary hires to be made for Foods, Hub and grade 7
- Extra office support has been approved which will ease the workload of the current office staff
- Metis Residency has been changed to May 12-16
- Current student enrollment is 822, with a prediction of in increase to 850 for fall 2025
- Grade 10 internship went well; a lot of work and many thanks to the community members who offer placements; students responded positively to the opportunity
- Aligning with CES on student placement for the upcoming school year. Creating class lists is a complex process. Students will be asked to list three friends who they learn best with and if parents have a specific request, they will need to phone administration to discuss
- 3R Assembly for grades 5-8 to recognize students demonstrating Respect, Resilience and Responsibility

- Question regarding support for current Athletic Director
 - → MS athletic director responsibilities will be removed and assumed by Shayla Osterman
